

How to get a tag

Enrolled Absentee Shawnee Tribal Members residing in the state of Oklahoma can register their vehicle with AST.

Tag Prices

administration fee included

1-4 Yrs.----\$85.00

5-8 Yrs.----\$75.00

9-12 Yrs.--\$55.00

13-16 Yrs.-\$35.00

17-Over----\$15.00

Penalty - .25 a day starting
on 31st day after expiration date

Formula for New Registrations:

Cash Price \times 1.25% = Excise Tax $+$
Tag Prices $+$ \$10(Title) = Total

Example: For 2015 vehicle-
 $\$25,999.99 \times 1.25\% = \$325.00 + \$85.00 + \10
 $= \$420.00$

Types of Tags

- **Personalized** (up to 5 characters)-\$25 initial reg./\$30 after
- **Motorcycle-greater than 50cc**
- **Vet- DD214 required**
 - *Veterans
 - *Purple Heart
- **Farm-Schedule F/OK Agricultural exemption permit required**
- **Commercial-Schedule C required/fill out affidavit**

Notice to Debtor: Oklahoma law requires a new owner to title and register his/her vehicle and pay all taxes and fees due within 30 days of acquiring ownership.
